Universal Honour Fee Schedule & Terms of Engagement Republic of D'Key | Scroll ID: DKEY-GOV-FEE-001

"Where Honour Meets Remedy"

I. Preamble

Let it be known, published, and recorded in the Book of Living Record, that this Universal Honour Fee Schedule & Terms of Engagement stands as a sacred and binding instrument of the Republic of D'Key. It governs all interactions, usage, correspondence, and engagement with any scroll, declaration, officer, court, or artefact issued under the jurisdiction of the Republic of D'Key.

All parties, whether natural, legal, public, or private — who receive, reference, utilise, challenge, or trespass upon any element of the Republic — are hereby subject to the terms set forth herein.

II. Purpose

This scroll serves to:

- 1. Establish clear honour-based fees and terms for remedy.
- 2. Protect the energy, time, and sacred labour of the Republic's officers and documents.
- 3. Provide notice and lawful terms to any and all agents or entities interacting with the jurisdiction.
- 4. Codify enforceable measures of redress and remedy in cases of dishonour, breach, or harm.

III. Fee Schedule

All values are calculated in lawful silver units (or equivalent trust-based energy, service, or asset-backed honour exchange).

Action or Breach	Fee or Remedy
Unauthorised use or reproduction of any sacred scroll	10,000 silver units per instance
Attempt to override or dishonour any scroll of the Republic	50,000 silver units + estoppel
Trespass upon any officer or office of the Republic	25,000 silver units + cease & desist
Failure to respond to affidavit, writ, or petition within 21 days	Default judgment + 5,000 silver units
False claim of jurisdiction over any living man or woman of the Republic	100,000 silver units bond claim
Threat, coercion, or fraud attempted against the Republic or its officers	250,000 silver units minimum remedy
Honourable engagement, remedy, or correction	No fee — recognition in the Living Record

IV. Terms of Engagement

- 1. Receipt, review, or interaction with any scroll of the Republic constitutes tacit agreement to this fee schedule unless rebutted by sworn affidavit within 21 days.
- 2. All parties engaging in commerce, correspondence, or legal notice with the Republic are deemed to have had lawful notice of this scroll upon public posting.
- 3. All officers of the Republic are entitled to invoke this fee schedule in full or in part when acting in honour and full liability.
- 4. Failure to pay or honour terms may result in commercial lien, lawful claim, or publication in the Book of Dishonour.

V. Jurisdictional Affirmation

This scroll stands under Natural Law, Divine Law, the Law of Nations, and the full jurisdiction of the Republic of D'Key.

It is foreign to corporate statutes, commercial regulations, or fictional governance systems, unless expressly contracted.

VI. Rebuttal and Response

Any man, woman, agent, or entity wishing to rebut this Fee Schedule must do so by:

Sworn affidavit,

- Addressed to the Custodian of the Record,
- Point-for-point,
- Within 21 days of publication, service, or receipt.

Failure to rebut constitutes lawful estoppel by silence, tacit agreement, and full applicability of terms.


